Groom & Bride

- Proof of ID: (Passport/Birth certificate)
- Proof of Address (Driving Licence/Utility Bill/Bank Statement)

Wali (Representative of the Bride) & 2 Male Witnesses (aged 18+)

A driving Licence will suffice, if the individual does not have a Driving Licence, then we will need to see a Passport (Photo ID) & an additional document as Proof of Address (Utility Bill/Bank Statement).

Fee Structure:

- **£250:** Nikkah's conducted within the Mosque
 - **£300:** Nikkah's conducted in another venue (home/banqueting hall)
- Please note a further charge may be applied for weddings conducted outside of the M25.
